The applicant must fall within the guidelines outlined below or requests for privileges will not be considered. Upon approval by the Club Secretary, Treasurer and Membership Chair, the prospective preview pass can be obtained via the Membership Services Office in the City House. Preview Pass cards will be granted for one 31-day period. Former members and prospects previously enrolled in the Prospective Preview Pass do not qualify.

Guidelines

A prospective preview pass is valid at the City House and Travers Island, open to new prospects only (not applicable to former members including those previously in the Leave of Absence or Prospective Preview Pass) in any class of membership with the following qualifications:

1. Prospective candidate (ages 21 and up) interested in applying for membership in any membership class must be sponsored by a NYAC member in good standing and who has been a member of the Club for a period of more than 12 months (except the Child of Member, Athletic, and Olympic membership categories).
2. Charges will be billed to an assigned Prospective Preview Pass account.
3. Must enroll in Direct Debit.
4. Spending Limit of \$750 per month.
5. Privileges not to exceed one 31-day period.
6. Must complete a background check (link to be e-mailed to candidate).
7. **Prospective candidates must provide a current letter of employment with the completed proposal.**

Member/Candidate Authorization

I hereby apply for a Prospective Preview Pass. In case of disciplinary action, privileges will automatically be voided. Upon application to the Club Secretary and subject to approval the privileges of all facilities at the City House and Travers Island may be extended to the preview pass holder. Privileges of Travers Island and its grounds are subject to week-days only, excluding holidays.

A 20% fee of the appropriate monthly dues or applicable minimum plus tax will be charged to the prospective pass holder's account on the approval date. A prospective preview pass holder so authorized may make charges to their temporary preview pass account and shall be furnished with a card of identification to be shown upon request. Applicable daily and monthly rates will apply for athletic facility use (6th floor gymnasium and fitness classes included). These privilege cards shall continue to be valid unless canceled either by the member or by the Club Secretary. Privileges will automatically be terminated on the day following the end of the 31-day period unless a membership proposal has been initiated.

I understand that any misrepresentation shall be cause for denial of further consideration or forfeiture of membership, as applicable. If elected to a prospective preview pass of the New York Athletic Club, I agree to abide and be bound by all By-Laws, House Rules and the Constitution, available for review on the NYAC web site.
